<u>Discussion – City Attorney's Legal Opinion on Gas and Oil Drilling</u>

At the request of City Council, Attorney Tom Hitch spoke to the memorandum he provided Council, dated September 18, 2015, regarding regulatory powers of the City of Mason as it pertains to the Exploration of Oil and Gas. He stated that he had not changed his opinion as he provided in May, stating that the City was without regulatory authority when it came to the bottom hole, being the bottom of the well, wherever that may be. Due to new technology, the bottom hole may be a distance away from the wellhead site. He gave a brief summarization of Chapter 38 of the Mason Code.

He reported on his consultation with a couple of Michigan oil and gas attorneys, who agreed that the City of Mason doesn't have jurisdiction, but that the Supervisor of Wells has full jurisdiction over all oil and gas wells including the prevention of waste of water and natural minerals.

Also, he consulted with Attorney Jim Olson of Traverse City, Michigan, who is a highly regarded environmental lawyer. The outcome was that Mr. Olson could cite no decisions that would make him believe that the research he had done was deficient or inadequate.

Discussion ensued. Clark thanked Attorney Hitch for his detailed memorandum on the matter. He suggested that staff look into the matter of issuing a permit for seismic testing. Mr. Price addressed comments that have come from residents at Council meetings to clarify what has been said over the last several weeks. He also clarified that there were residents that spoke and implied that the City had not done anything regarding the oil and gas concerns that residents had shared, stating that the truth is that Mason is ahead of most communities because an ordinance has been in place for many years that regulates oil and gas drilling.
